Student Right-To-Know

Student completion & graduation rates are published annually in the FFCU *Academic Catalog*. In compliance with the Student-Right-to-Know Act of 1991, FFCU reports the following graduation and retention rates.

Retention Rates for First-Time Students Pursuing Bachelor's Degrees = 67%

Retention rates measure the percentage of first-time students who are seeking bachelor's degrees who return to the institution to continue their studies the following fall. It does not include students who have transferred in from other institutions or part-time students. Please note that most FFCU undergraduate students are transfer students and we have a very low number of full-time, first-time degree seeking students. The rate is the percentage of first-time, full-time students who began studies in Fall 2020 and returned in Fall 2021.

Overall Graduation Rate

Known as the "Student Right to Know" or IPEDS graduation rate, this rate tracks the progress of students who began their studies as full-time, first-time degree- or certificate-seeking students to see if they complete an academic program within 150% of "normal time." Most FFCU undergraduate students are transfer students, and we have a low number of full-time, first-time degree seeking students. In fact, only 8% of entering students were counted as "full time, first time" in 2021. This can cause dramatic swings in this statistic.
